RULES & REGULATIONS

HJ's British Hairdressing Awards sponsored by Schwarzkopf Professional are recognised globally as the ultimate accolade in hairdressing. Since their launch over 40 years ago, the awards recognise the most credible names in the hairdressing industry.

WHO CAN ENTER

- Any qualified hairdresser who works within the regions outlined on page 3.
- Entrants must work in a commercial environment and have done so for a minimum of three years (excluding training).
- Entrants must have a regular client column within the region entered. This means working regularly with clients, in a salon, for a minimum of one day per week. This may be checked.
- Entrants can submit with one other stylist from their salon but cannot submit with any more unless entering the Artistic Team of the Year.
- Entrants must be over 18 years old at the time of the British Hairdressing Awards 2026. For Newcomer of the Year, entrants must be younger than 27 years of age, at date of entry.
- If you have cut and styled the hair and someone else has coloured the hair this is deemed as a joint entry and MUST be submitted as a joint entry (both names must be included on all entry forms – digital and print).
- An individual may only enter from one salon/space, in one region, in any given year. You can enter any number of the specialist categories.
- Winners recognised in the Hall of Fame can re-enter their chosen category after a two-year rest period.

YOUR IMAGES

- NEW FOR 2026: In most categories we have reduced the number of images required from eight down to six, with only four images needed for the first round. Please check your chosen category for the precise rules.
- Work submitted may be published work, with the exception of British Hairdresser of the Year, where only unseen collections can be submitted.
- Work submitted cannot have been entered into British Hairdressing Awards before (regardless of slightly different poses used or photographic treatments applied).
- Images entered, with the exception of Session Hairdresser of the Year, must have been photographed between 1 July 2024 and 26 June 2026.
- Replication of images across categories – a maximum of four images can be repeated across two categories, with the following exceptions:
 - Images entered into Newcomer of the Year or Avant Garde Hairdresser of the Year cannot be entered into any other category.
 - Images entered into Trend Image of the Year cannot be entered into any other category. You can only enter Trend Image of the Year once, in any one year.
 - Images entered into Men's Hairdresser of the Year can be entered into any other category, with the exception of Newcomer of the Year and Avant Garde Hairdresser of the Year.
 - All images entered into Schwarzkopf Professional British Colour Technician of the Year can also be entered into one of the regional categories (they cannot be entered in International Hairdresser of the Year nor any of the other specialist categories).

HOW TO ENTER

ENTRY DEADLINE: 5PM, FRIDAY 26 JUNE 2026

- STEP 1** Decide which category, or categories you would like to enter (entry is free).
- STEP 2** Read the specific rules and regulations for each category you wish to enter.
- STEP 3** Share a copy of the Rules and Regulations, ahead of your photoshoot, with your photographer. Consider requesting that your photographer also takes your headshot as part of the shoot. Photographers are requested to confirm that they have not retouched or manipulated the hair in any way, i.e. Although the hair colour or style cannot be altered, touch ups of other parts of the image is allowed.
- STEP 4** Create your entry (print and digital).
- STEP 5** Upload your entries digitally, all images and questionnaires (where applicable) to our online platform – bha.evessiocloud.com.
- STEP 6** Post your entries, each with their own entry form, crib sheet plus any relevant completed questionnaires, to:

WHAT TO KNOW BEFORE YOU SHOOT YOUR REGIONAL OR INTERNATIONAL COLLECTION

- Four images to be provided per entry collection; both digital and print formats.
- Please bear in mind that should you get through to the second round, you will be asked to supply a further two images (you may like to shoot all six images at the same time).
- If these images comply, they can also be entered into Schwarzkopf Professional British Colour Technician of the Year.
- Photographs may be black and white, or colour and the hair should be aspirational, wearable and reflect current trends. Professional photographers, make-up artists and stylists may be used.
- Ensure that nothing appears in the photographs that could be used to identify the entrant, e.g. branded gowns, branding reflected in mirrors etc.
- Images can be full length, but the hair should always be the focus.
- No more than two faces may appear in any one photograph.
- Hair work must be presented on real models (i.e. not training/doll heads or mannequins/AI). All images will be tested using an AI scanner.
- Wigs | Hairpieces | Strands – you must declare which photographs contain these by labelling the back of the photographs with the words 'wig' or 'hairpiece/strand'. The following rules must be followed; failure to do so will result in disqualification:
 - A maximum of three wigs may be used in total. This includes all six images, should you progress to the second round.
 - Hairpieces and strands can be used in one further image.

- If you are entering with one other stylist, please upload one image of you both together. This can be landscape (minimum 2000px width).

SPECIALIST CATEGORIES

AFRO HAIRDRESSER OF THE YEAR

WHAT TO KNOW BEFORE YOU SHOOT

- Entrants must work in a commercial environment, and have done so for a minimum of three years (excluding training).
- Entrants must have a regular column. This means working regularly with clients, for a minimum of one day per week. This may be checked by asking you to prove your appointment list.
- You must demonstrate how you offer and practice Afro/Textured-hair services. Please supply one of the following:
 - Screen shot of your service menu displaying Afro/Textured hair services
 - Your Instagram page displaying clients with Afro/Textured hair
 - Three reviews/testimonials from clients with Afro/Textured hair within the last 12 months of the entry deadline
- Work must be carried out on Afro hair.
- Four images to be provided per entry collection; both digital and print formats.
- Please bear in mind that should you get through to the second round, you will be asked to supply a further two images (you may like to shoot all six images at the same time).
- One image has to be completed on natural hair.
- One image must demonstrate the use of thermal/heat styling (silk press/relaxed etc.).
- Photographs may be black and white, or colour and the hair should be aspirational, wearable and reflect current trends. Professional photographers, make-up artists and stylists may be used.
- Ensure that nothing appears in the photographs that could be used to identify the entrant, e.g. branded gowns, branding reflected in mirrors etc. Images can be full length, but the hair should always be the focus.
- No more than two faces may appear in any one photograph.
- Hair work must be presented on real models (i.e. not training/doll heads or mannequins/AI). All images will be tested using an AI scanner.
- Wigs | Hairpieces | Strands – you must declare which photographs contain these by labelling the back of the photographs with the words 'wig' or 'hairpiece/strand'. The following rules must be followed; failure to do so will result in disqualification:

ARTISTIC TEAM OF THE YEAR

WHAT TO KNOW BEFORE YOU SHOOT

- A team requires a minimum of three people.
- Each member of the team must be a qualified hairdresser.
- All members of the team must have worked together for the same salon, salon group or recognised hairdressing body during the last 12 months (between 1st July 2025 and 26th June 2026.)
- Four images to be provided per entry collection; both digital and print formats.
- Please bear in mind that should you get through to the second round, you will be asked to supply a further two images (you may like to shoot all six images at the same time).
- Photographs may be black and white, or colour and the hair should be aspirational, wearable and reflect current trends. Professional photographers, make-up artists and stylists may be used.
- Ensure that nothing appears in the photographs that could be used to identify the entrant, e.g. branded gowns, branding reflected in mirrors etc. Images can be full length, but the hair should always be the focus.
- No more than two faces may appear in any one photograph.
- Hair work must be presented on real models (i.e. not training/doll heads or mannequins/AI). All images will be tested using an AI scanner.

AVANT GARDE HAIRDRESSER OF THE YEAR

If entering Avant Garde Hairdresser of the Year, your photographs cannot be entered into any other category.

- Photographs may be black and white or colour. Images should demonstrate progressive styling with an emphasis on innovation and technique. Professional photographers, make-up artists and stylists may be used.
- Ensure that nothing appears in the photographs that could be used to identify the entrant, e.g. branded gowns, branding reflected in mirrors etc.
- Images can be full length, but the hair should always be the focus.
- No more than two faces may appear in any one photograph.
- These images cannot be submitted into any other category.

MEN'S HAIRDRESSER OF THE YEAR

Images entered into Men's Hairdresser of the Year can be entered into any other category, with the exception of Newcomer of the Year, Trend Image of the Year and International Hairdresser of the Year.

WHAT TO KNOW BEFORE YOU SHOOT

- Work must be carried out on models who identify as male
- Four images to be provided per entry collection; both digital and print formats.
- Photographs may be black and white, or colour and the hair should be aspirational, wearable and reflect current trends. Professional photographers, make-up artists and stylists may be used.
- Ensure that nothing appears in the photographs that could be used to identify the entrant, e.g. branded gowns, branding reflected in mirrors etc. Images can be full length, but the hair should always be the focus.
- No more than two faces may appear in any one photograph.
- Hair work must be presented on real models (i.e. not training/doll heads or mannequins/AI). All images will be tested using an AI scanner.
- Wigs are not allowed.
- Hair pieces/strands can be used in a maximum of two images in total. This includes all six images, should you progress to the second round.
- You must declare which photographs contain the above by labelling the back of the photographs with the words 'Hairpiece/Strand'.

NEWCOMER OF THE YEAR

- Images submitted in the Newcomer of the Year category cannot be entered into any other category.
- Entrants to this category may not enter any other category.
- Previous winners of Newcomer of the Year cannot enter this category again.
- Entrants must be aged 27 years of age or under by Friday 26 June 2026.
- Entrants must be based in the UK and have been qualified for a minimum of two years and a maximum of five years.
- A photocopy of your passport or driving licence will be required to prove your date of birth; details of your client column will also be checked, and your salon owner/manager is required to sign and validate your eligibility for entry.
- Entrants are required to submit a total of four images. Should you reach the second round, no further images will be required.
