The perfect scheme to get your employees into electric and hybrid cars. The employee meets all costs from gross salary, saving tax, NI and other savings with no cost nor leaver risk for you.

We educate and engage with innovative strategies to encourage green choices. We also provide cars for a day, month, quarter, or another period for those who need a temporary situation to help meet your duty of care.



WHAT IS SALARY SACRIFICE?


Salary sacrifice schemes allow employees to exchange part of their gross salary for a brandnew car. This comes with everything included, from maintenance to tyres to insurance. The employee's take-home pay will be reduced due to gross salary payments, but they save on tax and NICs.

While always a taxable benefit, the government supports these schemes. For electric vehicles, there are lower Benefit-in-Kind (BIK) tax rates, just 3% from April 2025 - April 2026. Plug-in hybrids also benefit, with BIK rates between 6% and 15%, depending on the pure electric miles range. However, more polluting vehicles can face BIK rates of up to 37%, reducing most of the savings you could benefit from!

ELECTRIC CARS

Our mission is to transition UK workers to cleaner, greener motoring through electric cars, the most affordable and extensive option. With hundreds of models to choose from, electric cars are integral for daily life, not just work.

By combining salary sacrifice with ultra-low emission vehicles, employees can enjoy savings of up to 40% compared to retail prices, making electric cars more cost-effective than operating a 5-year-old diesel vehicle.



LEAVERS

Built in at 6% of the finance of the vehicle.

If an employee is dismissed or made redundant, we ask for 30 days' notice from the employer and we will collect the vehicle. If the employee leaves by choice, we still require 30 days' notice and charge a £250 collection fee.

SICKNESS/MATERNITY/ PATERNITY

Can be built in at 3% of the finance of the vehicle.

If an employee on Sickness or Maternity/Paternity leave has a salary too low to cover payments without falling below the Living Wage, you'll need to cover the costs until they return. You can arrange a reimbursement plan with the employee. The SMP protection will cost 3% of the finance, added to the employee's cost, and we will credit you for the payments. This lasts up to 9 months for maternity/paternity leave and 12 months for sickness, starting when deductions would drop them below the Living Wage. If they don't return after 9 or 12 months, we will take the car back.



WHY INTRODUCE THE SCHEME

Good employees are hard to find and keep. They want more than just a salary; they expect their employer to care about their mental and financial well-being and the environment.

Electric cars are becoming popular for company cars - why not add them to your benefits?



HOW DO I SET UP?

MANAGING YOUR SCHEME

We keep our scheme simple, but we need your involvement in key areas. Each month, you'll need to:

- Approve orders and ensure employees are permanent with sufficient salary.
- Action payroll sacrifice deductions (we'll calculate and advise).
- Pay us, usually by direct debit.
- Promptly advise us of any leavers.
