INFRASTRUCTURE

The manufacturing infrastructure of Group Companies (8) is spread over 90 acres of land with a built-up area of more than 1,00,000 sq. mts. The facilities consist of Raw material warehouses, Wash lines sections, spinning section, Draw line sections, Sorter sections – bottles / flakes, Glycolysis plant, Extruders, Tape Lines & Looms, Lamination section, Stitching, FIBC Bag Section, Printing, Spindle Lines, Boiler & TFH sections, Quality control (to perform strict quality checks at all stages during the entire manufacturing process) & R & D department, Electrical departments, Store section, Utility, STP, Parking, DG sets for power backup of more than 12 MW (for uninterrupted operations and prompt deliveries) and administrative blocks as main sections. We have ETP with UF and R.O. plants for 100% recycling of processed water to maintain a Zero Liquid Discharge (ZLD) across all our units. Sufficient number of transport aids like cars, LCVs, tractors, fork lifts, bulls etc. have been procured by the company for routine handling of materials and goods.

The Group has strong network of partners & own Collection centres to collect Post Consumer and Post Industrial waste for all plastic types. We are a family of more than 3000 people who are putting joint efforts for a better planet. The Goenka family also operate "Goenka welfare Society" for CSR and CER works. We have also developed accommodation facilities for our employees & workers.

I take you through the journey of Pashupati, a journey that I look back with immense satisfaction!

Trading began in late 1970s, however, it was in 2008 that we entered into the arena of manufacturing – woven fabrics and sacks was our initial foray. Here began our journey to learn and grow...and so we did! Our initial investment, was Rs. 160 Million, the turnover being Rs. 440 Million; processing capacity being 16,700 MTPA. We followed the principal of a very close connect with customers to fathom successfully... What he wants? How much does he want? When does he want?

We thus grew our products (rPSF, rPET flakes, rPET chips, masterbatches, yarns etc.) and explored markets...to reach where we are today, with the group's investment of Rs. 6,000 million delivering a turnover of Rs. 11,000 million with a processing capacity of around 2,00,000 MTPA; a 14-fold growth in 14 years! Our offerings include PET bottles to flakes, flakes to fibre, fibre to yarns, technical textile products, packaging solutions, masterbatches, rPET chips etc.

To most, CSR is a division; for us, it is our business itself; we today recycle close to 12 million PET bottles and around 3 million polyolefin bottles each day.

I sign off sharing with you our next milestone to achieve a turnover of Rs. 15,000 million with a processing capacity of 3,00,000 MTPA by 2024.
